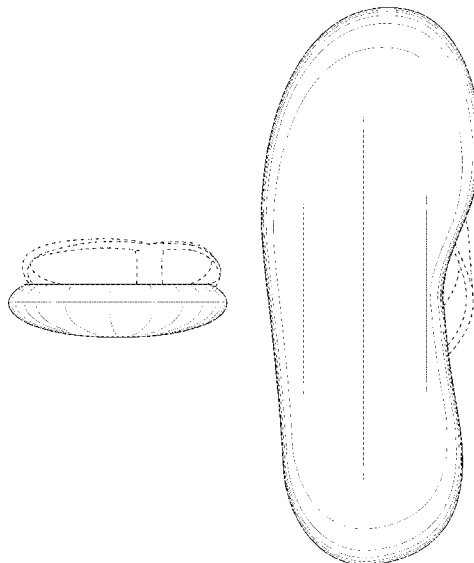
(57) **CLAIM**

The ornamental design for a footwear sole, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of one embodiment the footwear sole;
 FIG. 2 is an anterior (front) view of the footwear sole of FIG. 1;
 FIG. 3 is a posterior (rear) view of the footwear sole of FIG. 1;
 FIG. 4 is a top view of the footwear sole of FIG. 1;
 FIG. 5 is a bottom view of the footwear sole of FIG. 1;
 FIG. 6 is a medial view of the footwear sole of FIG. 1;
 FIG. 7 is a lateral view of the footwear sole of FIG. 1;
 FIG. 8 is a perspective view of another embodiment the footwear sole;
 FIG. 9 is an anterior (front) view of the footwear sole of FIG. 8;
 FIG. 10 is a posterior (rear) view of the footwear sole of FIG. 8;
 FIG. 11 is a top view of the footwear sole of FIG. 8;
 FIG. 12 is a bottom view of the footwear sole of FIG. 8;
 FIG. 13 is a medial view of the footwear sole of FIG. 8; and,
 FIG. 14 is a lateral view of the footwear sole of FIG. 8.
 In FIGS. 1-14, the details shown in broken lines are for illustrative purposes only and form no part of the claimed design. The embodiments of the footwear sole shown in FIGS. 1-14 are for a right foot. Embodiments of the footwear sole for a left foot are mirror images of the embodiments shown in FIGS. 1-14 about a sagittal plane of a human body.

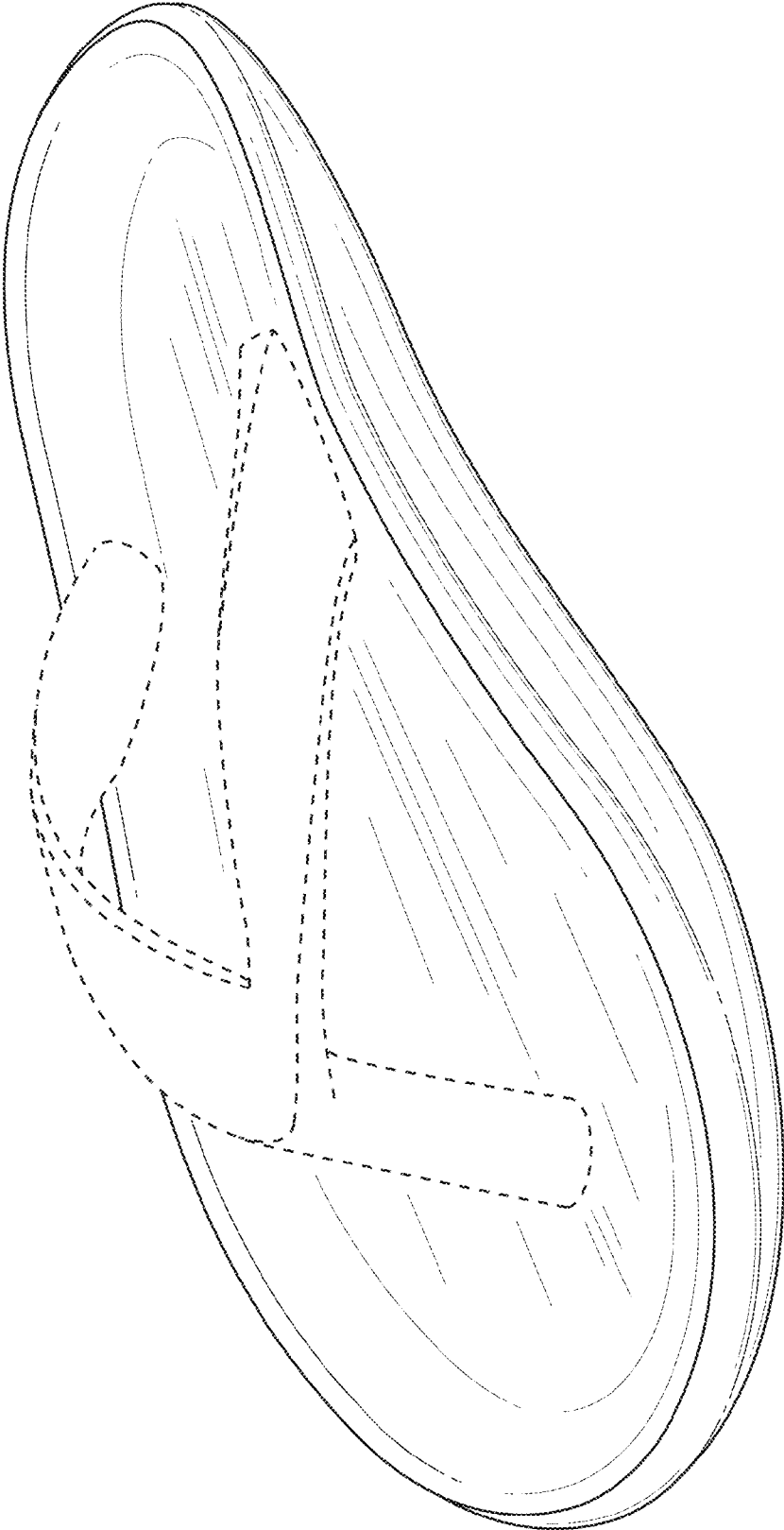

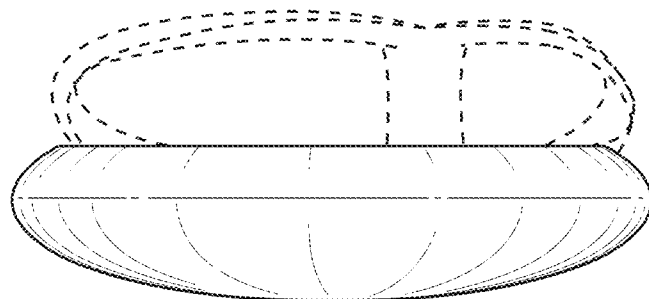

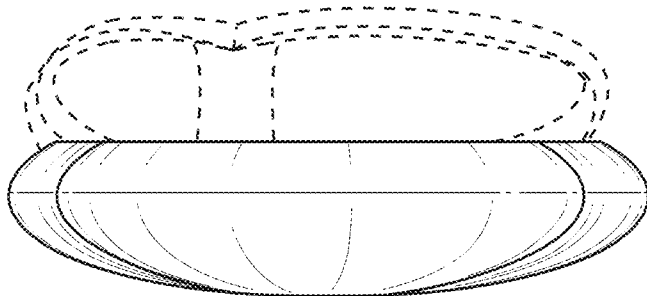

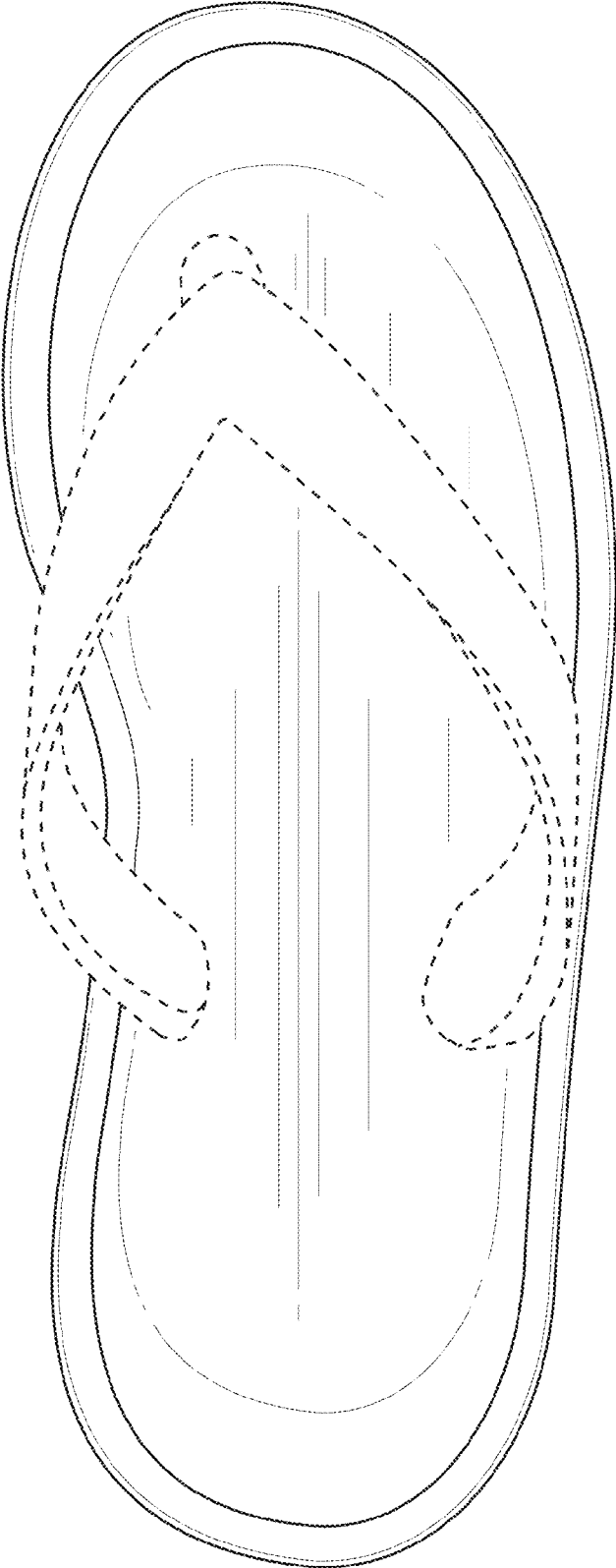

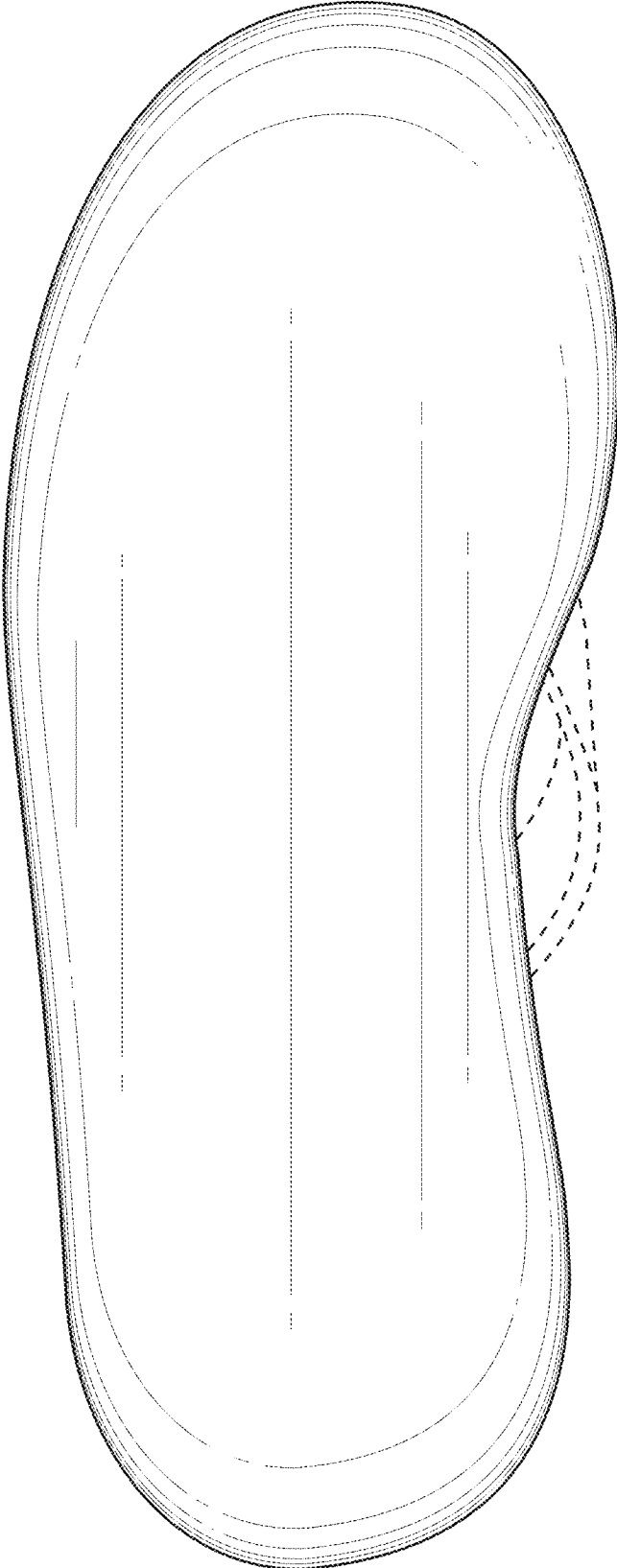

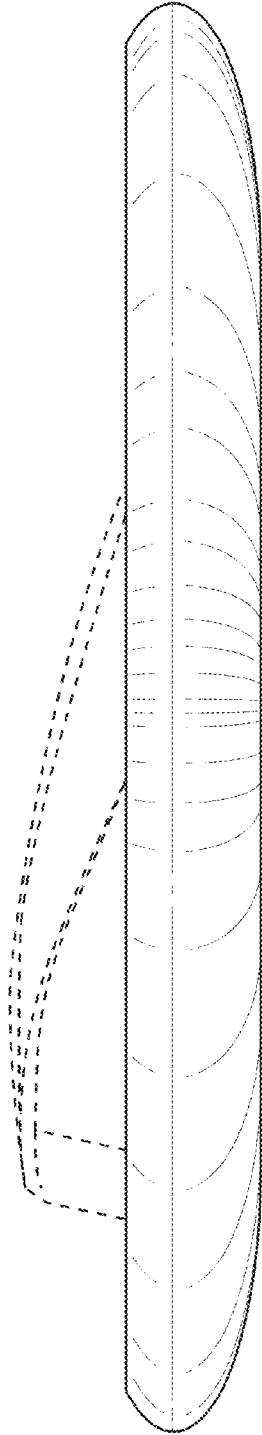

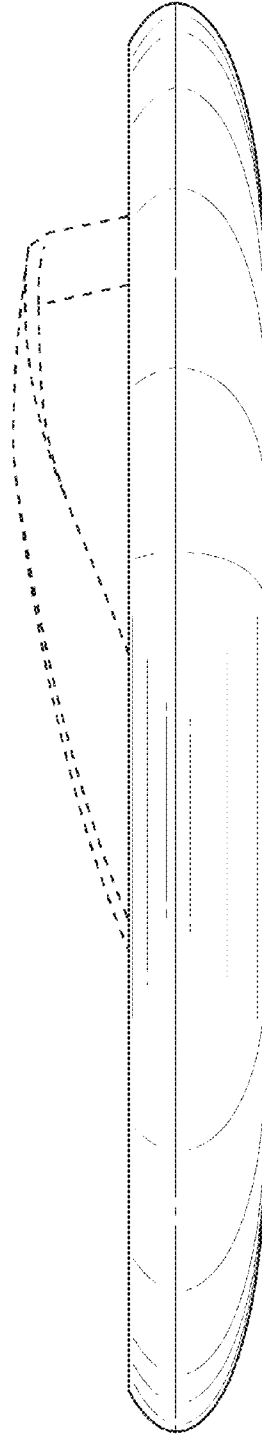

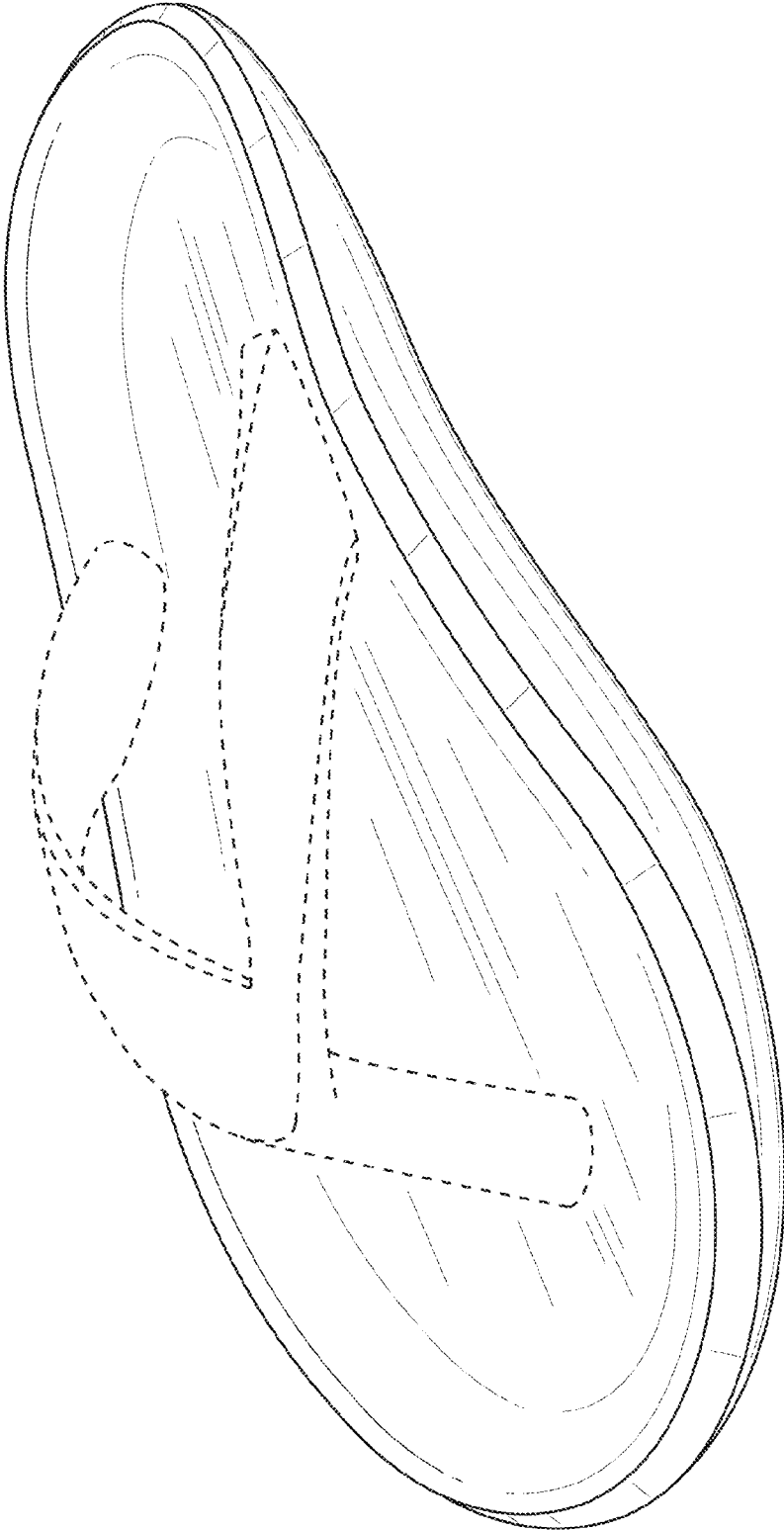

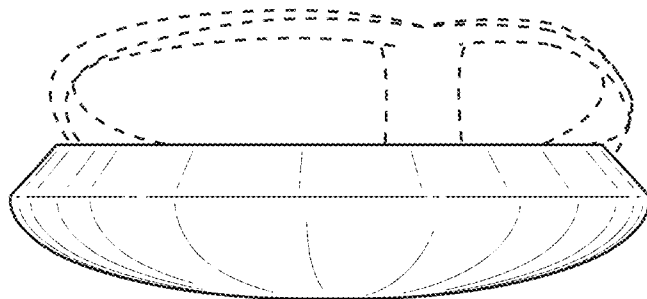

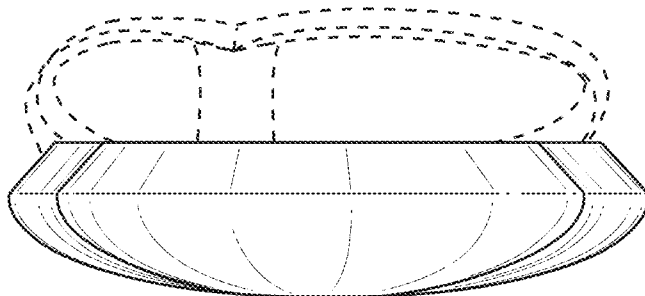

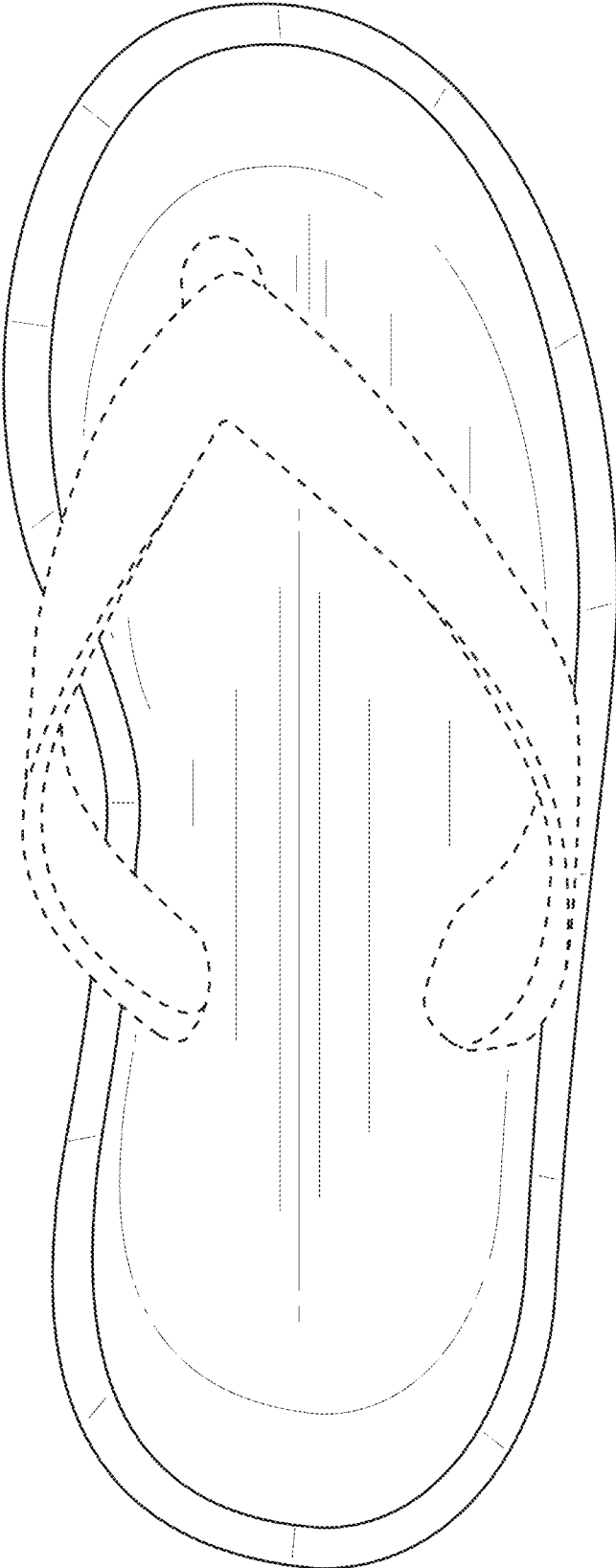

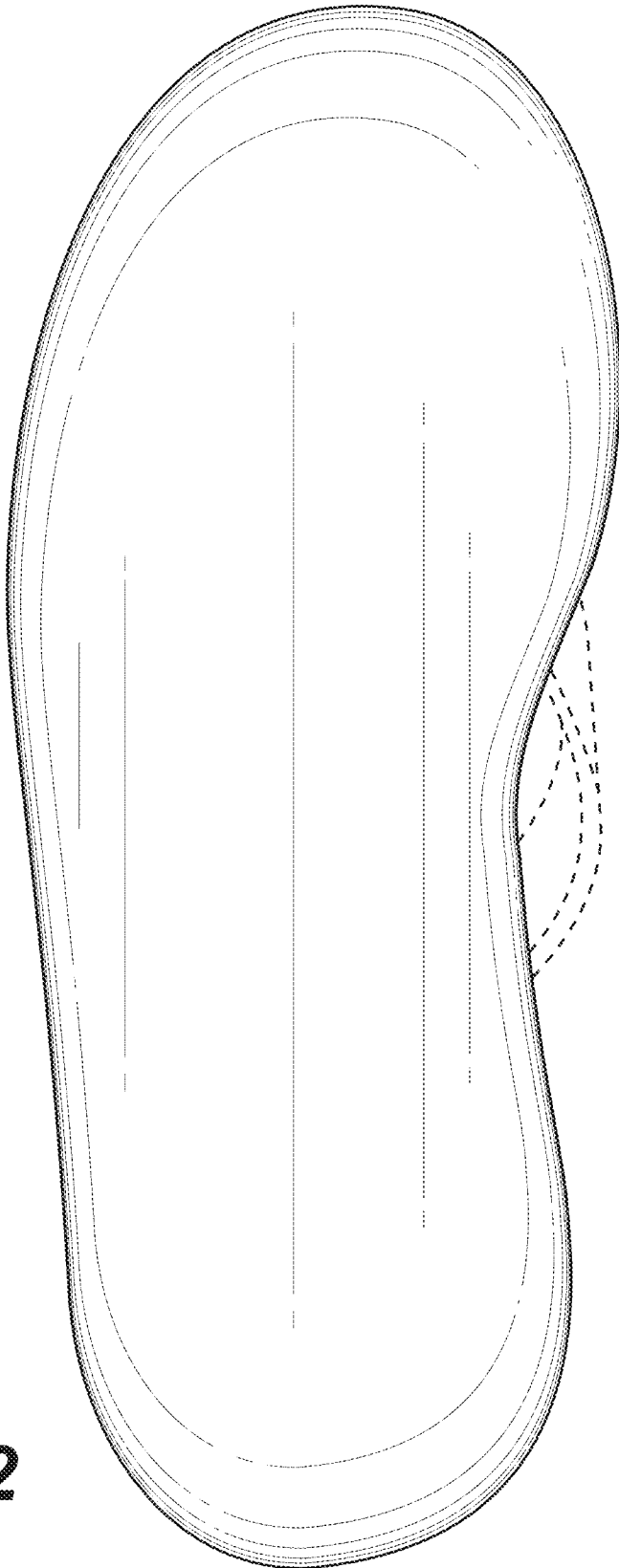

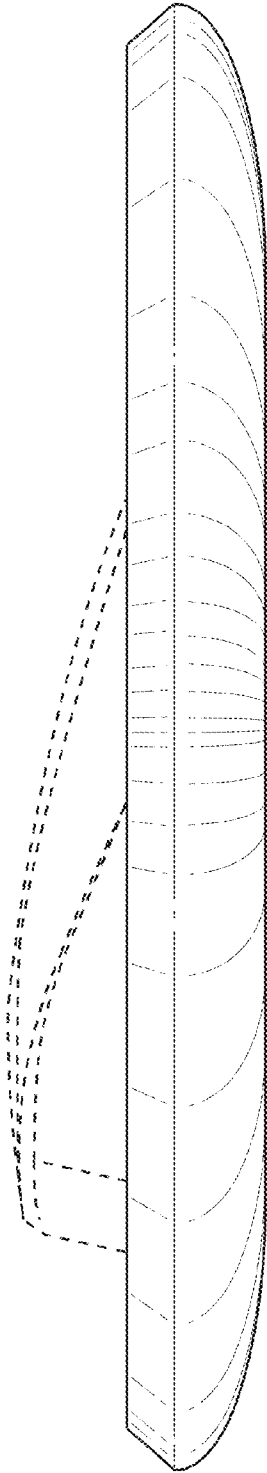

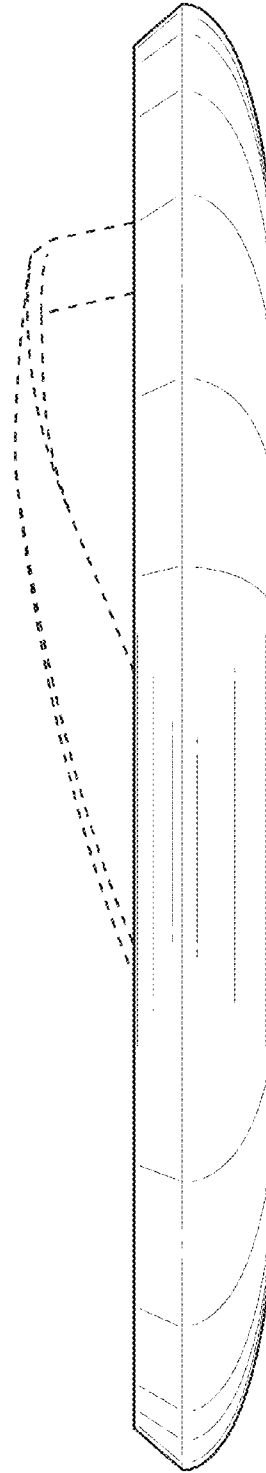
